College Credit Plus Chalker High School

2024/2025 School Year

What is College Credit Plus (CCP)?

- Allows students to earn college and high school credits at the same time by taking courses from Ohio colleges or universities.
- The purpose of this program is to enhance students' career readiness and post-secondary success, while providing a wide variety of options to college-ready students, at no or limited costs to students and families
- You may also travel to the college where you have been admitted or enroll in online courses offered by that college.

CCP details ...

- Students are permitted to take a maximum of 30 credits in one school year (between high school and college courses).
 - Must meet Chalker high school and athletic course eligibility requirements.
- Students can take courses that substitute for high school graduation requirements.
- CCP courses begin your college transcript and GPA. Every earned grade is a final grade to the college and the high school.

Students can apply to more than one college in one school year

CCP details ...

- Any student that drops a college course before the colleges drop date will remain in the course for high school credit.
- □ If a CCP course is failed, the student/family must pay for the course. The failed grade goes on your transcript for high school and college.

- If you wish to withdraw from a course and miss the drop date, you will be charged for the course and/or have a W/F on your transcript.
 This is your responsibility.
- **Acceptance into college and course placement are different.**

CCP details ...

If taking classes at a Kent Trumbull campus, <u>must</u> meet with your high school counselor to review your courses. Must give a copy of your scheduled college classes to your school counselor.

**Do not change your college courses without meeting with your high school counselor first

<u>Textbooks</u>

- □ If you are taking a course on campus or online with a college, **you** will need to order your textbook.
 - Order from campus bookstore and have it billed to Chalker High School
 - Send Ms. U a copy of your order confirmation

CCP details

Admission to college **does not guarantee placement in a course**

- Must follow the colleges guidelines and complete placement testing (typically math and science courses) as needed prior to being scheduled in a course.
- If a student does not meet the required testing score for a course, they will discuss alternative options with Ms. U

Will course credits transfer?

- Certain general education and technical courses will transfer, especially from one Ohio public college to another Ohio public college
- Students must check with colleges to confirm transferability
- Students should also visit <u>https://transfercredit.ohio.gov</u> for transfer information

CCP Risks

□ Failing a course will remain on record, at high school and college level.

Failing a course or receiving WF will require payment from family. Credit will need to be made up if it is a graduation requirement.

College course grades are factored into high school GPA and college GPA.

CCP Risks

- ❑ CCP Probation/Dismissal
 - Students who receive a 2.0 GPA in courses at the end of a semester or school year will be placed on CCP Probation.
 - The following semester, student will have the opportunity to raise CCP GPA by taking a course in different content area.
 - Student will be dismissed from CCP if 2.0 or below GPA is earned again.
 - Every school district has an appeal process.

CCP Rewards

- □ Students can reduce overall costs of college education.
- Students can reduce the amount of time to complete a college degree.
- Students can gain valuable experience working with rigorous content and build upon skills for college success.
- Can allow for flexible schedule options

Am I ready for CCP?

What is a "college-ready" high school student?

- Student should be self advocate
 - □ Independently seek out help when needed. Colleges have tutoring services available
- Mature Content
 - Content will not be modified for high school students
- Responsible
 - Deadlines and required information is your responsibility to **turn in on time**.
- Organization and study skills
 - check college emails often
 - □ Communicate clearly with professors/teachers
- Time Management
 - Consider school vs work vs personal activities/hobbies
 - Meet and manage deadlines in courses- typically very minimal late work accepted

What are CCP Requirements?

Meets College readiness benchmark in one of the following ways:

ACT English 18, Math 22, Reading 22

SAT Writing/Reading 480, Math 530

Accuplacer Writing 263, Math 263, Reading 250

OR

3.0 Cumulative GPA

2.75-2.99 Cumulative GPA and received A's and B's in

OR

Test Optional:

Minimum unweighted, overall high school GPA of 3.0 and minimum core GPA of 2.0 are eligible, no test scores required

OR

***Core GPA** uses grades only from English, math, science, social studies & any foreign language classes completed

Test Required:

Minimum unweighted, overall high school GPA of 2.0, and minimum core GPA of 2.0, and meet one of the six following college readiness

- the six following college readiness benchmarks
- (1) ACT English score of 18
 (2)Math score of 22
 (3)Reading score of 22
 (4) SAT Evidence-based Reading & Writing score of 480
 (5) SAT Math score of 530
 (6) YSU Accuplacer score of 250 (free through YSU)

CCP Transfer:

Overall college GPA of 2.0 from another college/university, plus and overall, unweighted HS GPA of 2.75 and core GPA of 2.0. Students not meeting the GPA requirements must qualify under the Test Required category *Visit the YSU CCP webpage for more information

<u>April 5, 2024</u>

Registration deadline by March, 2024

What are my next steps?

1. Must turn in the CCP Intent to Participate Form to counseling office

By April 1st

1. Must apply to the college of choice and await admission decision

*YSU Fall Application deadline - April 15th, 2025

*YSU Spring Application deadline - October 31st, 2025

*Kent Fall Application deadline - June 1st, 2025

*Kent Spring Application deadline - October 15th, 2025

What are my next steps?

3. Must register for ACT exam if needed -April is last exam accepted for CCP

Is required if you do not have a 3.0 GPA.

4. Must meet with your high school counselor to review which courses you plan to take through CCP.

Admission to college **does not guarantee placement in a course**

Must follow the colleges guidelines and **complete placement testing** as needed prior to being scheduled in a course.
